



Dear Foalbook Stallion Owners,

Below is the Stallion activation form for the upcoming breeding year. Your signature on the below forms means that you have read and agree to comply with the KWPN-NA breeding and registration rules.

Registration of offspring: In general the offspring by activated Foalbook Stallions are eligible for Register B. However, if the stallion is approved with an Erkend Studbook, foals may be eligible for Register A if the stallion is activated for breeding with the KWPN-NA (\$300). If you think your stallion qualifies, please check with the office and fill out the activation form for Approved/Licensed stallions

Activation: Stallions in North America must be activated for breeding with the KWPN-NA annually in order for their foals to be eligible for registration with the KWPN-NA. Stallions must be activated on an annual basis. Activation includes submission of a signed activation form and payment of stallion dues.

Deadlines: Activations are due by October 31st. Dues for activation received by the deadline will be \$250, and will include a listing in the Foalbook Stallion section of the Stallion Directory. Stallions with activations received after the November 30th deadline will not be listed.

Advertising: Foalbook stallions are not be listed in any KWPN-NA advertising. Advertising of Foalbook stallions is not accepted for inclusion in the Stallion Directory, however farm advertising will be accepted.

Feature Articles: If your stallion is performing well at higher levels in sport we would like do a short feature article in the newsletter. If so, please submit a short article and a high quality photograph. If the photograph is copyrighted, we will need a signed release from the photographer.

Breeding Reports: After activation, you will receive a packet containing the Report of Mares Bred and the Stallion Service Certificates (you may also submit as an excel file). Service Certificates release the breedings and allow registration of foals by your stallion. In other words, do not send the mare owner their stallion service certificate if the mare owner has not completed your contract. The KWPN-NA will not register the foal without a copy of the certificate. Some stallion owners send the certificate out upon completion of the contract; other stallion owners send the certificate after the mare owner has reported the birth of the foal to them. The completed reports are due in the KWPN-NA office by October 31st of the breeding year.

Mare Surcharges: Whether or not the mare surcharges are included in the breeding fee, the stallion owner/agent is responsible for collecting the surcharges and submitting them to the KWPN-NA office along with the breeding report. Birth Declarations are not mailed to breeders until surcharges are paid.

DNA: The KWPN-NA office must have DNA on file for any stallion activated for breeding.

EVA procedures: EVA procedures must be followed according to the protocol devised by the American Horse Council as described in the enclosed documentation and the Stallion Directory. This means that if a stallion is vaccinated he must be vaccinated annually. If a stallion is not vaccinated he must be tested annually.

Deadlines, Fees and Benefits

**Activation Agreement and Check must be received in the KWPN-NA office by dates below.
Deadlines will be strictly adhered to. Activation includes one full membership.**

Activation Rules for Foalbook Stallions – All Types

The annual activation requires stallion owners to commit themselves to uphold the regulations of the KWPN and KWPN-NA. A signed copy of this agreement must be on file with the KWPN-NA office and annual stallion dues must be paid in order for a stallion's offspring to be eligible for Registration. Breeding Reports and Stallion Service Certificates will be sent to all owners of activated stallions. Breedings may also be reported on an Excel spreadsheet and emailed to the office.

It is advisable to report all breedings to the KWPN-Office, but mark those mares for which the mare owner wishes to register the resulting foal with the KWPN-NA. A breeding surcharge of \$75 is due for each mare whose owner wishes to register the resulting foal with the KWPN-NA. Completed breeding reports and surcharges are due at the KWPN-NA office by October 31 of the breeding year. There is a \$50 fine for breedings reported after October 31 and a \$25 per mare fine for surcharges paid after October 31 of the breeding year. The stallion owner is responsible for the paying surcharges on mares to the KWPN-NA office – whether the surcharge is included in the stud fee or is to be paid on top of the stud fee.

By signing this agreement the stallion owner/agent agrees to comply with all the rules of the KWPN-NA and KWPN. If the stallion owner does not comply with the KWPN-NA and KWPN rules, the stallion may not be eligible for activation in a following year and foals resulting from the breedings during that season will not be eligible for registration.
