



## ***Dear Approved/Licensed Stallion Owners,***

Below is the Stallion activation form for the upcoming breeding year. Your signature on the below forms means that you have read and agree to comply with the KWPN-NA breeding and registration rules.

**Activation:** Stallions in North America must be activated for breeding with the KWPN-NA annually in order for their foals to be eligible for registration with the KWPN-NA. Stallions must be activated on an annual basis. Activation includes submission of a signed activation form and payment of stallion dues.

**Deadlines:** Activations received by the October 31st deadline will be \$300, and will include an individual page in the Stallion Directory (B&W) and on the Website (color). Dues for Activations received after the October 31st deadline but before November 30 will be \$400, and will also include a page in the Stallion Directory and on the website. Dues for activations received after November 30<sup>th</sup> will also be \$400, but these stallions will have a page on the website only.

Activation fees for KWPN foalbook stallions fully approved with an Erkend Studbook are \$300. Stallions will receive half a page in the Stallion Directory.

**Submitted information:** Official inspection information about activated stallions will be published, as well as sport information submitted by the owner. If your stallion was in last year's Directory, please make changes or additions on the below form, on last year's page or by email. If this the first year your stallion is activated, please give as much detailed information as possible. Verifiable sport results for the stallion and/or his offspring may also be emailed. The information provided will be edited to fit the space available in the Stallion Directory. Stallion and offspring sport results in the Directory are limited to about 2,000 characters and spaces.

**Websites:** If you have a website, please provide us with the address so we can publish it in the Directory and link to it from your stallion's web page.

**Advertising:** Advertising for Approved/Licensed stallions and farms is available in the Directory will be accepted until November 15th.

**Photos:** Photos must be of high quality and horizontal format is preferred; minimum size 5" x 7" with a minimum of 300 dpi or 1500 x 2100 pixels. TIFF, EPS and JPEG files are accepted on CD or DVD. Photos may also be submitted as a glossy print. Copy-righted photos must be accompanied by a release for both print and web usage.

**Breeding Reports:** After activation, you will receive a packet containing the Report of Mares Bred form. Stallion Service Certificates are no longer required. Some stallion owners send the certificate out upon completion of the contract; other stallion owners send the certificate after the mare owner has reported the birth of the foal to them. The completed reports are due in the KWPN-NA office by December 1st of the breeding year.

**DNA:** The KWPN-NA office must have DNA on file for any activated stallion.

### Deadlines, Fees and Benefits

**Activation Agreement, Check, Sport Information and Photo must be received in the KWPN-NA office by dates below. Deadlines will be strictly adhered to.**

# Activation Rules for Approved/Licensed Stallions

The annual activation requires stallion owners to commit themselves to uphold the regulations of the KWPN and KWPN-NA. A signed copy of this agreement must be on file with the KWPN-NA office and annual stallion dues must be paid in order for a stallion's offspring to be eligible for Registration. Breeding Reports and Stallion Service Certificates will be sent to all owners of activated stallions. Breedings may also be reported on an Excel spreadsheet and emailed to the office.

It is advisable to report all breedings to the KWPN-Office, but mark those mares for which the mare owner wishes to register the resulting foal with the KWPN-NA. By signing this agreement the stallion owner/agent agrees to comply with all the rules of the KWPN-NA and KWPN. If the stallion owner does not comply with the KWPN-NA and KWPN rules, the stallion may not be eligible for activation in a following year and foals resulting from the breedings during that season will not be eligible for registration.

Photos are kept on file. New stallion photos must be of high quality. Horizontal format is preferred. Photos must be a minimum size of 5" x 7", minimum of 300 dpi or 1500 x 2100 pixels. TIFF, EPS and JPEG files are accepted on CD or DVD. Photos may be also be submitted as a glossy print. A copy-righted photo must be accompanied by a release for both print and web usage.
