



Expedited Transfer or Registration Service

KWPN of North America offers an expedited document service that guarantees the processing and return of transfer of ownership, duplicate papers application or registration of a new horse within 48 hours (2 business days) ***provided all necessary documentation is submitted at the time the application is received*****. It is your responsibility to get any necessary additional paperwork (microchip affidavits, DNA kits) back to KWPN of North America or other named company in a timely manner. The cost of the expedited service will be \$100.00 in addition to any other related fees (i.e. registration fees, transfer fees, membership fees and/or duplicate fees.) ***Expedited service is only guaranteed if all of the requirements for the service are met***. In a case where one or more of the requirements have not been met, KWPN-NA will contact the person submitting the application and attempt to resolve the issue immediately. The \$100 expedited fee is non-refundable even when requirements are not met so please review all of the requirements carefully before requesting the expedited service.

**** 1. Transfers of ownership** in which all documents are in order will be processed the day they are received. The new papers will go out FedEx the following day (or same day if time allows).

****2. Duplicate paper applications** in which all documents are in order AND a microchip scan is submitted will be processed the day they are received. The new papers will go out FedEx the following day (or same day if time allows). Duplicate paper applications in which all documents are in order and HAIR is submitted will have DNA kits ordered same day. The new papers will go out FedEx *the day after the DNA result is received from UC Davis (or same day if time allows)*.

**** 3. Registrations** in which all documents are in order will be **started** the day they are received. DNA kits and microchipping kits will be sent same day. The papers will go out FedEx *the day after DNA results AND the microchip affidavit have been received (or same day if time allows)*.

Applications for all services are available on the KWPN of North America website or an application may be obtained from the KWPN of North America by fax, mail or email. The application must be correctly completed, must be legible and must be mailed or faxed back to KWPN-NA at the address or fax number listed on this form along with this Expedited Service Form. Services are payable by check, MasterCard, Discover or Visa and payment must be submitted at the time of application. When KWPN-NA receives this completed application with all of the required documentation and verifies all of the information, the service will be initiated.
