Check with KWPN-NA for specifics. Parentage and veterinary requirements must be completed prior to keuring to be accepted in the studbook, earn ster, keur or elite predicate or be in Top Fives.

Stallion Approval - stallions aged two years and older. Age _____

Open to KWPN Foalbook and Register A stallions and stallions registered with an Erkend Studbook. Pedigree approval is a pre-requisite to keuring presentation for all stallions. Veterinary requirements must be completed prior to presentation for full approval.
