INFORMATION REGARDING STALLION CLASSES:

Advice keuring- Your stallion must have had his pedigree evaluated in the spring to be eligible for this class. Any stallion 2 or older that has had his pedigree evaluated is eligible for the advice class. **There is NO free jumping for 2 year olds in the SP/HP directions. SP/HP stallions 3 years or older presented for the advice class WILL free jump unless presented in IBOP.** This class does not guarantee eligibility for licensing in following years. Stallions will be expected to be presented for hard surface evaluation, conformation evaluation and free movement (Harness type stallions will not be judged on free movement). General Soundness Exam should be completed and submitted to the KWPN-NA office for this class. Stallions are not required to complete veterinary examinations for this class (besides soundness exam), but it is optional to start gathering vet tests September of the 2 year old year forward.

Licensing- Your stallion must have had his pedigree evaluated in the spring to be eligible for this class. Any stallion 3 or older that has had his pedigree evaluated is eligible for the licensing class. Stallions will be expected to be presented for hard surface evaluation, conformation evaluation and performance test. If your stallion has a sport record, please include that with this entry.

- Unless your stallion has a sport predicate, he **MUST** perform an IBOP on the day of the keuring. Other performance classes are optional. Please see the keuring booklet for expectations of an IBOP. **Stallions presented for licensing do NOT free jump.**
- IBOP for Gelders stallions includes 2 driving tests OR dressage and jumping tests. Please inform us of which option you choose.
- IBOP for Harness stallions will include a two-part driving test over two days. Invitations for the second day of testing will be given upon successful completion of Day 1.
- Positive feedback in the licensing class does not guarantee licensing. Information is taken back to the KWPN Stallion Committee in Holland and evaluated.
- PROK, D-OC, endoscopy and general soundness exam are all required for completion of licensing requirements. These veterinary requirements can be completed any time from September of the 2-year-old year to 30 days post-keuring. These veterinary requirements are available on the KWPN-NA website. Please reach out to the KWPN-NA office for any clarifications or questions.
- Upon successful presentation in a licensing class, the stallion may be subject to an on-site blood test for prohibited substances. This will be done at the expense of the KWPN-NA.

Please be advised that results of the licensing and advisory classes are not published. Stallions in these classes are not eligible for Top Ten awards. Any performance class that the stallion performs is still eligible for awards.

If your stallion is selected for licensing and has passed all required veterinary tests, your stallion's offspring will now be eligible for Register A papers upon official notification from the KWPN or KWPN-NA. He will be expected to be presented in a performance class at a keuring or (for riding types) at the North American Stallion Sport Test (if age appropriate) for several years post-licensing as well as present a group of foals for evaluation (10 different offspring for all riding types, 5 for harness types) over a period of 3 years. Licensing may be rescinded if requirements are not fulfilled. Full approval will be considered if the stallion, at age 7 or older, is competing successfully at Prix St. Georges or Intermediare I/1.40m jumping and has presented the required number of offspring with results deemed acceptable by the KWPN jury. Riding type stallions can be referred for a 5-day character test at the North American Stallion Sport Test.

This Agreement is executed on the date last below written by the undersigned in favor of **The KWPN of North America** (hereinafter 'KWPN-NA') and **Koninklijk Warmbloed Paardenstamboek Nederland** (hereinafter 'KWPN') with regard to participation in a Keuring or Inspection (hereinafter 'Inspection').

PARTICIPANT'S COVENANTS

In consideration for being permitted to participate in the inspection, the undersigned acknowledges, agrees and represents that he or she is aware of the intrinsic dangers of equine activity, which dangers or conditions are an integral part of equine activities including but not limited to: (i) the propensity of equines to behave in ways that result in injury, harm or death to persons on or around them; (ii) the unpredictability of an equine's reaction to such things as sounds, sudden movement, unfamiliar objects, persons or other animals; (iii) certain hazards such as surface and subsurface conditions; (iv) collisions with other animals, objects or persons; and (v) potential of a participant acting in a negligent manner that contributes to injury to the participant or others, such as failing to maintain control over the equine or not acting within the participant's ability.

Section 1. Release and Covenant Not to Sue.

The undersigned hereby releases, waives, discharges, and covenants not to sue KWPN or KWPN-NA, its promoters, participants, owners, judges, hosts, staff, facility or jury hereinafter referred to as 'Releasees' from all liability to the undersigned and the undersigned's personal representatives, assigns, heirs, and next of kin, for any and all loss or damage, and any claims or demands therefore on account of injury to the person or property of the undersigned, or resulting in death of the undersigned, whether caused by the negligence of the Releasees or otherwise, while participating in the Inspection event.

Section 2. Indemnification.

The undersigned hereby agrees to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage or cost they might incur due to the presence of the undersigned in the Inspection activity, whether caused by the negligence of the Releasees or otherwise.

Section 3. Assumption of Risk.

The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence of Releasees or otherwise, while participating in the Inspection activity.

Section 4. Media Release

By signing this release, I understand this permission signifies that any photographic, audio or video recordings taken during the inspection of myself, or my horses may be electronically displayed via the Internet or in any public setting.

The undersigned has read and voluntarily signs a release and waiver of liability and indemnity agreement and further agrees that no oral representations, statements, or inducements apart from the foregoing written agreements have been made.
